POSITION

This role is within the Dutch branch of Lloyds Bank GmbH in Amsterdam. You will report to the Head of Marketing & Business Development and be part of the Marketing & Business Development Department.

The Product Owner of the Loans Feature Team takes the lead in the Loans Feature team and the requirements analysis, process design, delivery of loans related product and process developments and/or loans related projects in order to realise customer value through excellence and execution. Includes using business analysis skills to identify the business need, analyse requirements, through to assessing/designing/testing, prioritising and implementing agreed solutions.

During delivery the Product Owner will ensure value is maximized, will drive to reduce lead time, sustain quality and ensure delivery is in line with the agreed risk appetite and Group's risk management framework.

Playing a key part in supporting Lloyds Bank in becoming the Best Bank for Customers by demonstrating the behaviours expected within the Colleague Identity Framework, and living the Bank Values.

KEY ACCOUNTABILITIES

- **Improvement & Innovation:** Identifies shortcomings, then suggests and implements improvements to existing business practices, systems and procedures while developing and delivering projects and changes within the Loans Feature Team
- **Product & Solution Development:** Analyses and evaluates the feasibility/relevance of proposals for all changes for loans related products, processes and services, then develops and amends as necessary and supervises activities performed by the Loans Feature Team
- **Growing capability:** Takes responsibility for implementing the Loans Feature Team's development framework with guidance from senior colleagues, and informally coaching the LFT members in area of Agile/ Scrum methodology/ expertise
- **Data Collection & Analysis:** Analyses key loans related themes using data from a wide range of sources and identifies possible impacts on the business
- **Needs Assessment:** Uncovers emerging issues and/or needs and identifies potential causes, related issues, key stakeholders and barriers
- **Solutions Analysis:** Identifies and evaluates complex expertise-led solutions against a range of criteria to find the ones that best meet business needs

- **Risk Management & Analysis:** Develops and/or delivers a contingency plan for significant aspects of the risk management and/or control process
- **Regulatory & Compliance Management:** Investigates standard and non-routine incidents and reports and provides expert advice to more senior colleagues while coordinating with all internal functions to facilitate effective implementation of compliance programmes to minimize risk exposures and ensure adherence with regulatory standards.
